1 Introduction

This draft paper is intended to provide a general overview on the current and potential trade situation, and an even more general overview on FDI between CER and MERCOSUR¹.

Both regions have or are currently undergoing deep reforms involving the role of the State and extending their economic links with the world. In both cases there is a bilevel or "biringged" concept for such opening to freer trade: 1.- the closer region: Southern Cone of South America and the Tasmanian region respectively, 2.- the "second ring" area: South America and the Americas, South East and East Asia. We must recognize nevertheless that CERTA has an important advantage over MERCOSUR: its "second ring " is the most dynamic region in today's world.

At the same time there is room for a "horizontal" or South Hemispheric linkage that could be useful to balance excessive weight or asymmetric relationships in the second rings between the southern and northern counterparts: The USA in the Americas, Japan and the USA in Asia Pacific. In other terms: linkages between MERCOSUR and CER seem to be possible in a more leveled playing field.

The impending partnership with Chile will make MERCOSUR part of the Pacific Basin, setting the appropriate scenario to develop this "horizontal path" even if further integration within the Americas, "the vertical path", is still sought.

The following factors should be raised in the consideration of the mutual relationship between the two regions, considered until now as non complementary and competitive:

- the potential to intraindustry trade, based on product differentiation. There is a huge difference between traditional - neoclassical trade - and new trade creation factors. Intraindustry trade could involve similar products in the added value chain vg. final foodstuffs, inputs for further processing and shipping to the same or third markets, with reciprocal advantages in each region access,
- the potential for intrafirm trade, based in increasing FDI flows, and aimed to produce for each host region first and second "rings".
- investment in resource related activities: mining, forestry, agribusiness; or services, infrastructure, communications.
 - market diversification,
 - transfer of technology in agribusiness, telecommunications, mining, fisheries.


What are the main obstacles?

Lack of direct transport links, lack of mutual knowledge of opportunities, the prevailing and stubborn "traditional" competitive - non complementary view and the crowding out of resources and capabilities ought to the "discovery" of intraMERCOSUR economic space for MERCOSUR members and the Asian scenario for CER members, can be counted as the main stumbling blocks to the advance of the relationship. Maturity of the economic reforms in both sides and in the integration within the "first ring", and actual investments already been made, could indicate that the time is ripe to inaugurate a new stage to develop a South America - South Pacific economic space.

2- MERCOSUR and CER: size of economies and trade².

Total value of trade is roughly similar in both regions: in 1995 total trade of MERCOSUR was us\$ 144.4 billions, while CER's reached us\$ 138.0 billions.

Although both MERCOSUR and CER intraregional trade grew since the signature of each agreement, in the case of MERCOSUR annual growth was 25% while CER's was 12%. As a result, MERCOSUR intraregional actual trade doubles CER's, while at the end of the 80's were both similar.

Billions of us\$.


Intraregional trade is far more significant for MERCOSUR -8.8% of its total trade- than for CER -4,8% of its total trade-. That seems reasonable if we look both at the population figures -MERCOSUR has almost ten times more people than CER- and to the economic size of both regions -MERCOSUR GDP(1995) is us\$ 942 billions and CER us\$ 390 billions-. Global size hide big differences in per capita income (PPP), which is

almost four times higher in CER than in MERCOSUR (us\$ 18,500 against us\$ 6,100). CER per capita GDP is still more than double of Argentina's whose human development indicators are the best of MERCOSUR.

Measured by the ratio of exports to GDP, CER -17%- is a much more open region than MERCOSUR -9%-. The gap is even wider when the export/population ratio is considered: Exports per inhabitant are us\$ 393 in MERCOSUR, against us\$ 3,074 in CER.

Intraregional trade for each individual country of MERCOSUR³ and CER grew more than extraregional trade, meaning that integration was an actual factor in the deviation of trade but in the framework of growing trade flows:




Graphic II: MERCOSUR Total and Intraregional Trade.


The direction of trade (see annex) follows different patterns: while CER is "Asia addicted" - 2/3 of its exports go there -, MERCOSUR even if "Europe minded" - one third of its exports are shipped to the EU -, has a more diversified pattern. The U.S. is the market of one fifth of MERCOSUR exports, doubling the share it has in CER's case, but still far from being in a dominant position. **Asia has a similar share than the US in the exports of MERCOSUR**.

CER suppliers are much more diversified than its buyers: roughly a quarter of its imports come respectively from North America, the EU and Asia while a fifth of imports comes from Japan. Meanwhile, North America and Europe are the origin of almost two thirds of MERCOSUR purchases (a third each). **The desirability of suppliers diversification is clear in this case.**

Both the market share of MERCOSUR in CER and viceversa are quite small: the us\$ 412 millions shipped in 1995 were 0.60% of total exports of MERCOSUR, and only 0.58 % of the CER imports. Meanwhile CER exported us\$ 416 millions to MERCOSUR, less than 0.77% of its total exports and 0.55% of the MERCOSUR imports.



During the last years merchandise flows in both directions did not seem to follow any clear upward pattern:

As shown, MERCOSUR exports reached a peak in 1989, while 1993 and 1995 were the years of maximum value of imports from CER. Trade balance have resulted in continuos surplus for MERCOSUR since 1981, except for 1992, 1993 and 1995. But this general figure hide a normal deficit situation for Argentina and Uruguay, balanced by Brazil huge surplus. Paraguay trade with CER is nil.

Merchandise trade pattern.

Resource based products are predominant in trade between MERCOSUR and CER. Tables in the Annex describe at six digits of the Harmonized System the main current patterns, the share of each product in each partner's country market and, in the case of Argentina and Brazil, the potentiality of exports to Australia and New Zealand, based on the revealed competitive advantage in each case and in the room for extending their market share.

Potential trade increases or addition of new products, as indicated in the Annex tables could be based in the currently existing static comparative advantages and in the current direction of trade. As could be suspected, items with higher RCA are mainly those already traded and resource based: fish, leather, tea.

But even on the base of current trends, exports of some products with supposedly a lower static comparative advantage (but with a RCA > 1) could be enhanced if a government-business strategy is introduced on both sides of a new partnership MERCOSUR - Tasmanian. Processed foods, finished or semifinished steel products, electrical appliances, compressors, construction materials and engines are part of the potential new supply of MERCOSUR. Telecom, mining and agriculture equipment are included in the possible diversification of ANZ supply.

Nevertheless, over this "static advantage based" trade scenario we must superpose the decisive role that FDI will have on commercial flows in the coming years. FDI derived is today roughly two thirds of world trade⁴ (one third within the transnational corporation system, the other with TNC as one of the partners). Why MERCOSUR - CER trade won't follow a similar pattern, once a steady flow of FDI is established?

3. Australia and New Zealand investment in Argentina⁵

A listing of current Australia investment in Argentina include mainly mining ventures, foodstuffs and services (cinemas). New Zealand groups are involved in development of forestry and paper resources.

Due to lack of complete data - Argentina does not require any prior registration of FDI projects -, the following list is probably incomplete but it gives an approach of current trend and amounts involved. (See Table on Annex II, page 97).

Compared to total outward investment of Australia (almost 6 billions us\$ in 1994) and New Zealand (us\$ 207 millions) the figures are blatantly small.

North America TNC are still the main source of MERCOSUR FDI inflows: between 40 and 50% of FDI in Argentina, and around 40% for Brazil. Chile is becoming a growing source of foreign investment in MERCOSUR.

Annex III. A brief Summary of MERCOSUR



The Southern Common Market -MERCOSUR- comprises Argentina, Brazil, Paraguay, and Uruguay, featuring a combined population of about 200 million, a surface of 11.9 million km², and a per capita GDP of U\$S 4,373 (Argentina: U\$S 8,030; Brazil: U\$S 3,641; Paraguay: U\$S 1,693; and Uruguay: U\$S 5,175).

MERCOSUR is the result of a long-standing economic and social relationship between these four countries, dating back to colonial times, when trade began to expand, especially along the borders. Throughout history the MERCOSUR member countries have always been able to overcame sporadic episodes of conflict and political turmoil through trade and social interrelations.

As of 1960, after a long era of bilateral agreements, Latin American countries began to create mechanisms for economic integration and trade liberalization. First, the Latin American Free Trade Association (ALALC) was founded in 1960, and then the Latin American Integration Association (ALADI) was established in 1980.

In 1985, the Argentine and Brazilian governments decided to accelerate their economic integration efforts, bearing in mind that their combined strength would also increase their negotiating power with third parties. A Joint Commission for Bilateral Integration and Cooperation was created, whose proposals became the basis of the agreements for bilateral integration signed between Argentina and Brazil in July of 1986.

The agreements considered tariff reductions, sectoral programs of industrial complementation, the establishment of binational companies and cooperation in the fields of trade, energy, transportation, communications and development of technology.

From 1985 to 1990 additional agreements were signed, dealing with such matters as commercial preferences, investments and technology, further contributing to the integration process.

In July of 1990, Argentina and Brazil signed an agreement to establish a common market by 1995, whereby all tariffs and non-tariff barriers for all goods would be eliminated on a bilateral step-by-step basis, and all technical rules and trade policies would be harmonized.

Paraguay and Uruguay joined Argentina and Brazil, signing the Treaty of Asunción in March 1991, thus creating the Southern Common Market MERCOSUR. The four countries decided that a common market would be set in motion as of January 1, 1995. Movements of labor, goods, capital, and services would be unrestricted.



To that end, the following steps were laid out:

- Dismantling tariffs and non-tariff barriers through a Trade Liberalization Program for lowering tariffs on a gradual, automatic, and lineal basis, and for eliminating non-tariff barriers.
- · Establishing a common external tariff.
- Adopting common trade policies with regard to third countries or blocs of countries.
- Coordinating positions in regional and international economic and commercial forums.
- Coordinating macroeconomic and sectoral policies, including foreign trade, agriculture, industry, taxes, currency, foreign exchange, capital, services, customs, transportation, communications, and others, in order to create the appropriate conditions for competition between the member states.
- Harmonizing the legislation of the member states.
- Creating a conflict settlement system.

As of January 1, 1995, Argentina, Brazil, Paraguay and Uruguay started to operate as a customs union: intra-regional tariffs were eliminated, and a common external tariff was established.

The common external tariff (CET) ranges from 0% to 20% for the import of most products.

Nevertheless each country still applies national tariffs different from the CET on some goods. These tariffs will be gradually lowered to reach the CET level by the year 2001. Three hundred items defined by Argentina and Brazil, around 1000 items by Uruguay and 399 items defined by Paraguay; and capital goods are in this situation. The CET convergence deadline for computing and telecommunications goods is extended to the year 2006.

On October 1, 1996, Chile signed a Free Trade Area agreement with MERCOSUR. Exceptions to free trade are listed in 12 annexes to the agreement, according to the sensibility level of the products whose barriers are going to be phased out. MERCOSUR countries also reached a free trade agreement with Bolivia, even if of more limited scope than the one with Chile.

Negotiations with Colombia, Ecuador, Perú and Venezuela are under way; the MERCOSUR proposal includes eliminating tariffs, and any other similar barriers, over a 10-year period, reducing non-tariff barriers on a gradual basis, adopting coordinated trade policies, harmonizing technical rules, and creating a free trade zone. With Mexico trade negotiations are under way, albeit not aiming to a FTA.

MERCOSUR and the European Union signed an agreement in Madrid, on December 15, 1995, implementing a political dialogue at level of Heads of State and designing a framework to identify instruments aiming at the definition of the terms and conditions for greater economic cooperation between them.

On occasion of the Summit of the Americas, the Presidents and Heads of State of the Americas resolved to take steps towards creating the "Free Trade Area of the Americas". In January of 1995, work was begun to determine the convergence and divergence areas, and to formulate recommendations on the progress of cooperation and liberalization. The Meeting at Belo Horizonte in May 1997 signed the beginning of a new negotiating modality, in which the private sector has been an active participant, alongside the official negotiators. Political decisions are expected to be taken at the Heads of State summit to be held in Chile in early 1998.
